## SALES CONDITIONS

DUE TO STATE LAW, SLWS IS PROHIBITED FROM SHIPPING DIRECT TO AGENCIES FOR INDIVIDUALS IN: CA, NJ, MO, PA, MA, WASH. DC. FIREARMS MUST SHIP TO VALID (FFL) FEDERAL FIREARMS LICENSED DEALER.

ALL SALES ARE SUBJECT TO STATE AND LOCAL MAGAZINE RESTRICTIONS

ALL CA FFL'S MUST SUBMIT CALIFORNIA DEPARTMENT OF JUSTICE REGISTRATION LETTER AND LARGE CAPACITY MAGAZINE PERMIT

LAW ENFORCEMENT OFFICERS WHO CHOOSE TO ACQUIRE THEIR PRIVATE DUTY WEAPONS WITH THEIR AGENCY'S PERMISSION, MAY PURCHASE GLOCK PISTOLS ON A PREPAYMENT BASIS FROM SLWS, INC.; PROVIDED THAT THE GLOCK PISTOL(S) SHIPPED TO LAW ENFORCEMENT OFFICERS WILL NOT BE RESOLD TO THE GENERAL PUBLIC AND COMPLY WITH A.T.F. AND STATE PURCHASE AND SHIPMENT REGULATIONS. INDIVIDUAL OFFICER SALES ARE CONSIDERED AS RETAIL SALES AND ARE SUBJECT TO FEDERAL EXCISE TAX, AND STATE AND/OR LOCAL SALES TAXES.

A.T.F REGULATIONS, SALES OF FIREARMS TO LAW ENFORCEMENT OFFICERS:

SECTION 925(A) (1) OF THE GUN CONTROL ACT EXEMPTS LAW ENFORCEMENT AGENCIES FROM THE TRANSPORTATION, SHIPMENT, RECEIPT, OR IMPORTATION CONTROLS OF THE ACT WHEN FIREARMS ARE TO BE USED FOR THE OFFICIAL BUSINESS OF THE AGENCY.

THE REGULATIONS AT 27 CFR 478.134 PROVIDE: IF A LAW ENFORCEMENT OFFICER IS ISSUED A CERTIFICATION LETTER ON THE AGENCY'S LETTERHEAD, SIGNED BY A PERSON IN AUTHORITY WITHIN THAT AGENCY, STATING THAT THE OFFICER WILL USE THE FIREARMS IN PERFORMANCE OF OFFICIAL DUTIES, THEN THAT OFFICER SPECIFIED IN THE CERTIFICATION MAY PURCHASE A FIREARM REGARDLESS OF THE STATE IN WHICH HE/SHE RESIDES OR IN WHICH THE AGENCY IS LOCATED. SLWS IS NOT REQUIRED TO PREPARE A FORM 4473 COVERING THIS PARTICULAR SALE, AS THE CERTIFICATION LETTER IS EVIDENCE OF THE TRANSACTION. DISPOSITION TO THE OFFICER'S AGENCY IS ENTERED IN SELLER'S PERMANENT RECORD, AND THE CERTIFICATION LETTER WITH AN "ORIGINAL SIGNATURE" IS KEPT IN THE SELLER'S FILES.

THE A.T.F. CONSIDERS THE FOLLOWING AS PERSONS HAVING AUTHORITY TO MAKE CERTIFICATIONS THAT THE LAW ENFORCEMENT OFFICER PURCHASING THE FIREARM WILL USE THE FIREARM IN THE PERFORMANCE OF OFFICIAL DUTIES:

1. IN A CITY OR COUNTY POLICE DEPARTMENT, THE DIRECTOR OF PUBLIC SAFETY OR THE CHIEF OR COMMISSIONER OF POLICE.
2. IN A SHERIFF'S OFFICE, THE SHERIFF.
3. IN A STATE POLICE OR HIGHWAY PATROL DEPARTMENT, THE SUPERINTENDENT OR THE SUPERVISOR IN CHARGE OF THE OFFICE TO WHICH THE OFFICER IS ASSIGNED.
4. IN FEDERAL LAW ENFORCEMENT OFFICES, THE SUPERVISOR IN CHARGE OF THE OFFICE TO WHICH THE FEDERAL OFFICER IS ASSIGNED.

THE A.T.F. WOULD ALSO RECOGNIZE SOMEONE SIGNING ON BEHALF OF A PERSON OF AUTHORITY PROVIDED THERE IS A PROPER DELEGATION OF AUTHORITY AND OVERALL RESPONSIBILITY HAS NOT CHANGED IN ANY WAY. COPIES/FAXES OF LETTERS AND "RUBBER STAMP" SIGNATURES ARE NOT ACCEPTABLE.
